A competition is open for the attribution of 1 Research Grant in the framework of the NORTE-01-0145- FEDER-000036, with reference CORAL - Sustainable Ocean Exploitation: Tools and Sensors, within the R&D Institution CIIMAR (Interdisciplinary Centre of Marine and Environmental Research), supported by the Northern Regional Operational Programme (NORTE2020), through the European Regional Development Fund (ERDF), according to the following conditions:

1. Scientific area: Biological Sciences

2. Admission requirements

The candidates must hold a Master Degree in the field of in Biological Sciences, or related fields with minimum final classification of 13/20.

The candidate must have a strong technical and scientific training on Bioinformatics. A demonstrated experience to prepare reports and write manuscripts is expected.

3. Work plan:

The candidate will mainly be involved in the investigation plan of CORAL, namely working with Bioinformatics and Molecular Biology in Metazoans and their exploitation by xenobiotics. The biotechnological relevance of Nuclear Receptors will be expected.

Duration of four (4) months, starting in September 2018, under the regime of exclusive dedication, non-renewable.

7. Monthly maintenance stipend:

The monthly maintenance allowance is €980 (nine hundred and eighty Euros – Taxe Free), in agreement with the monthly maintenance stipend table of the grants directly attributed by FCT, I.P. within the country (http://www.fct.pt/apoios/bolsas/valores.phtml.en).

The ranking of candidates will be performed by a global evaluation based on the evaluation of the Curriculum Vitae (50%), experience in the research field (50%).
