# **RESEARCH GRANT (BI) (1 vacancy)**

#### Reference: INSEAFOOD/BI-MSc/2018-055

A competition is open for the attribution of 1 Research Grant in the framework of the **Structured Program of R&D&I INNOVMAR - Innovation and Sustainability in the Management and Exploitation of Marine Resources, reference NORTE-01-0145FEDER-000035**, namely within the Research Line **INSEAFOOD Innovation and valorization of seafood products: meeting local challenges and opportunities**, within the R&D Institution CIIMAR (Interdisciplinary Centre of Marine and Environmental Research), supported by the Northern Regional Operational Programme (NORTE2020), through the European Regional Development Fund (ERDF), according to the following conditions:

#### 1. Scientific area: Biological Sciences;

#### 2. Admission requirements

1) The candidates must hold a Master Degree in the field of Aquatic Biology or similar, compatible with the objectives and tasks of the project, with minimum final classification of 14/20;

#### Additional (preferential) requirements

 Technical, scientific and management experience in technological or scientific projects in the area of Aquatic Biology, ideally in aquaculture, specifically in oyster culture;
 Experience with tools in the area of information and communication technologies (elearning); iii) Driving license (category B).

#### 3. Work plan:

The work to be developed includes Support to all activities predicted in the Work Package 7 of this project, mainly as follows:

1) Planning of trial demonstrations of results achieved by the project;

- 2) Preparation of codes of Good Manufacturing Practices and Good Hygiene Practices for oyster aquaculture production;
- Development of professional training (e-learning), in collaboration with the seafood industry;
- 4) Industrial application of aquaculture production and products according to quality standards.

Tasks to be accomplished:

- 1) Validation of the results from laboratory trials under commercial conditions;
- 2) Elaboration and revision of Codes of Best Practices;
- Information and communication technologies and e-learning tools applied to oyster farming;
- 4) Gastronomic demonstrations for consumers;
- 5) Dissemination, writing and publication of the achieved results;
- 6) Participation in general management activities.

The work includes the collection and organization of bibliographic elements, contacts with aquaculture and fish processing companies, as well as active participation in meetings, conferences and other forms of dissemination of the results, writing of reports and scientific articles, and direct contact with the all other project activities and partners.

## 9. Selection methods:

The ranking of candidates will be performed by a global evaluation based on:

- 1) Evaluation of the Curriculum Vitae 30%;
- 2) Experience in the technical or research field 30%;
- 3) Interview 40% (Only the 3 top listed candidates will be interviewed).

The jury reserves the right to not assign the grant depending on the quality of the applications.
