

### **RESEARCH GRANT (BI-Graduate) (1 vacancy)**

A competition is open for the attribution of 1 Research Grant in the framework of **INOVATION ACTION nº 773400 SEAFOOD**<sup>TOMORROW</sup>, funded by the European Commission through the call H2020-BG-2016-2017/H2020-BG-2017-1, for the R&D Institution CIIMAR (Interdisciplinary Centre of Marine and Environmental Research), according to the following conditions.

### 1. Scientific area: Food Sciences

#### 2. Admission requirements

The candidate should have:

- a) A graduate degree in the field of Food Science and Technology, Biochemistry or related fields;
- b) Be highly motivated and demonstrate technical capacity to perform analytical work on food products;
- c) Experience in seafood science and technology; seafood quality and safety; independent capacity on chemical, instrumental and sensory analyses of raw materials and final seafood products; data processing and statistical analysis;
- d) Demonstrated capacity to prepare reports and write manuscripts;
- e) Fluency in Portuguese and English (both speaking and writing);
- f) Proven record of organizational responsibilities.

#### 3. Work plan:

The candidate will collaborate in the development of new seafood products; perform sensory and chemical analyses and instrumental texture measurements; data processing and statistical analysis. The candidate will be also particularly involved in demonstration/dissemination activities. The candidate will prepare reports and write manuscripts for publication in national/international journals.

#### 4. Legislation and official rules:

Law nº. 40/2004, 18th August (Research Fellowship and Studentship Regulation) and amended by Law No. 202/2012, 27th August; Regulations for Studentships and Fellowships of the Fundação para a Ciência e a Tecnologia, I.P. — 2015 and CIIMAR Grants Regulation.

#### 5. Work place

The work will be carried out at CIIMAR, under the scientific supervision of Maria Leonor Nunes coordinator of Aquaculture and Seafood Quality Group. Part of the experimental work will be developed at Divisão de Aquacultura e Valorização (DivAV) of IPMA under the scientific supervision of Amparo Celeste Gonçalves.

#### 6. Duration of the contract:

Duration of six (6) months), under the regime of exclusive dedication, eventually renewable according to legal terms up to the end of the project.

## 7. Monthly salary:

The monthly maintenance allowance is € 752,38 (seven hundred, fifty two Euros and thirty eight centimes– Taxes Free), in agreement with the monthly maintenance stipend table of the grants directly attributed by FCT, I.P. within the country (http://alfa.fct.mctes.pt/apoios/bolsas/valores).
