

## Research Grant (BI) (1 vacancy)

### Reference: A&B/BM/2019-006

A competition is open for the attribution of 1 research grant in the framework of the Project **“O Mar e o Litoral, Arquitectura e Biologia Marinha: O Impacto da Vida do Mar no Ambiente Construído”**, reference **PTDC/ART-DAQ/29537/2017**, within the R&D Institution CIIMAR (Interdisciplinary Centre of Marine and Environmental Research), supported by COMPETE 2020, PORTUGAL 2020, FEDER and FCT through national funds, according to the following conditions:

**1. Scientific area:** Biological Sciences, Bioinformatics

### 2. Admission requirements

The candidates must hold a BSc in the field of in Biological Sciences or related fields, with a final classification of at least 12 values and work experience in Bioinformatics. In detail the candidates must have and demonstrate training and/or experience in the following subjects:

- Experience in transcriptomics of aquatic, vertebrates and invertebrates, organisms (Preparation of pipelines to analyse RNA-Seq data; Transcriptome assembly and annotations)
- Experience in Genomics of aquatic organisms (Preparation of pipelines to analyse WGS data; Genome assembly and annotations).
- Experience in management and use of High-performance computer (preferentially in *CentOS* distribution) and software and/or programming languages (R or shell script).
- Evolutionary data analysis;
- Fluency (speaking and writing) in English.

The jury reserves the right to close the application in case none of the candidates meets the desired profile.

In the event the doctorate degree was awarded by a foreign higher education institution, said degree must comply with the provisions of Decree-Law no. 66/2018 of 16th August until the signature of the contract.

### **3. Work plan:**

The candidate will be involved in intensive bioinformatics work. The candidate will be expected to carry out several tasks including NGS dataset assembly, sequence analysis and comparative genomics.

### **4. Legislation and official rules:**

Law n.º. 40/2004, 18th August (Research Fellowship and Studentship Regulation) amended and republished by [Decreto-Lei n.º 202/2012](#), 27<sup>th</sup> August; Regulations for Studentships and Fellowships of the Fundação para a Ciência e a Tecnologia, I.P. — and CIIMAR Grants Regulation approved by FCT.

### **5. Work place:**

The work will be carried out at CIIMAR, Edifício do Terminal de Cruzeiros do Porto de Leixões, Av. General Norton de Matos, s/n, Matosinhos, integrated in the Aquatic Ecology and Evolution Group, under the coordination of Dr. Elsa Froufe and Dr. Filipe Castro.

### **6. Duration of the contract:**

Duration of one (1) year, starting in May, 2018, under the regime of exclusive dedication.

### **7. Monthly salary:**

The monthly maintenance allowance is €980, in agreement with the monthly maintenance stipend table of the grants directly attributed by FCT, I.P. within the country (<http://www.fct.pt/apoios/bolsas/docs/RegulamentoBolsasFCT2015.pdf>). Payment will be made monthly by bank transfer. In addition to this allowance, the grantee will be covered by a personal accident insurance.

### **8. Selection methods:**

The ranking of candidates will be performed by a initial evaluation based on:

- Evaluation of the Curriculum Vitae (EC) -70% (which is eliminatory);

The Evaluation of the Curriculum Vitae will be performed according to the following criteria:

- Value of the final BSc classification (BSc) - 20%.
- Demonstrated experience in handling bioinformatic pipelines - 40%
- Published papers/Publication track records in the area are a plus, especially on the scope the project, i.e. Sardine and Sargasso (PPP) – 30%.
- Motivation letter (ML) – 10%.

The Evaluation of the Curriculum Vitae will be performed according to the following criteria:

$$EC = [20\%BSc+40\%ELAH+30\%PPP+10\%ML]$$

In the second phase and after the sorting of the candidates following CV evaluation, there will be an interview to the maximum of three candidates if they are separated by less than 10% according to the jury criteria. All the factors will be pondered according to the formula:

$$INT = 30\%$$

The final score (CF), expressed in a number from 0 to 20, will weight in the Curriculum Vitae evaluation (70%) and the interview (30%):

$$CF = 70\%EC+30\%INT$$

If the candidates do not show up in the interview they will be withdrawal from the application, being excluded from the competition.

## 10. Form of Advertising/notification of results:

The final results of the evaluation will be published through a list sorting the candidates according to their attributed mark, on the CIIMAR website and by e-mail;

After the announcement of the results, candidates are considered automatically notified to, if they wish to do so, comment on the results on a preliminary hearing period within 10 working days after that date, as provided for in the Código do Procedimento Administrativo.

The jury reserves the right to not assign the grant depending on the quality of the applications.

In case of resignation or withdrawal of the selected candidate, the next candidate with the highest evaluation score will be notified immediately.

Based on the final sorted list of the candidates it will be made a reserve list that will be used for the future recruitment of grantees for this project.

## 11. Deadline for application and presentation of applications:

The competition is open from **27 february until 12 march 2019**. The applications must be formalized, compulsorily, by sending the following documents:

- detailed Curriculum vitae with clear specification of i) list of peer reviewed publications, books and/or reports proof the experience in the above-mentioned fields ii) list of the computer skills (software and/or programming languages for simulation and data analysis)
- copy of the eligibility certificates;
- motivation letter;
- one or more reference contact information of current or past supervisors;
- contact e-mail address and phone number;
- indication of the reference of the competition (as indicated in this announcement).
- any other documents that the candidates may recognize as relevant to demonstrate the adequacy to the function
