A competition is open for the attribution of 1 Research Grant in the framework "HIPERSea – Collection and Life Support in a Hyperbaric system for Deep-Sea Organisms" within the R&D Institution CIIMAR (Interdisciplinary Centre of Marine and Environmental Research), supported by POCI (Programa Operacional Competitividade e Internacionalização), COMPETE 2020 and Portugal 2020, according to the following conditions:

1. Scientific area: Biological Sciences and Engineer

2. Admission requirements

The candidates must hold a master's degree in the field of Biological Sciences, and be enrolled, at the time of application, in a doctoral program, aiming at consolidating their scientific training through the development of research work leading to the achievement of the respective academic degree, or being enrolled in non-academic degree courses integrated in the educational project of a higher education institution developed in association or cooperation with one or more R&D units.

The candidate must have technical and scientific knowledge on the use of experimental systems in marine sciences.

A demonstrated experience to perform experiments both in the laboratory and field, use of biochemical and molecular biomarkers and experience in deep-sea campaigns and projects is an advantage.

Very good fluency in English is expected.

3. Work plan:

The candidate will mainly be involved in experiments of deep-sea ecology/ecotoxicology and development of new hyperbaric systems for deep-sea research/maintenance of deep-sea organisms.

4. Legislation and official rules:

Law no. 40/2004, 18th August (Research Fellowship Holder Statute) in its current version, FCT Regulation for Research Studentships and Fellowships and CIIMAR Grants Research Regulation.

Whenever the degree of the candidate selected for the position is from a foreign institution it needs to be recognized by a Portuguese higher education institution accordingly to the Decree-Law no. 66/2018 of 16th August until the signature of the contract.

5. Work place:

The work will be carried out at CIIMAR, Av. General Norton de Matos, s/n, Matosinhos, under the scientific supervision of Prof. João Coimbra and Prof. Miguel Santos

6. Duration of the grant:

Duration of six (6) months, starting in April 2020, under the regime of exclusive dedication, eventually renewable according to legal terms up to the end of the project.

7. Monthly maintenance stipend:

The monthly maintenance allowance is €1064 (one thousand and sixty four Euros), in agreement with the monthly maintenance stipend table of the grants directly attributed by FCT, I.P. within the country https://www.fct.pt/apoios/bolsas/valores .

8. Selection methods:

The ranking of candidates will be performed by a global evaluation based on the evaluation of the Curriculum Vitae (40%), experience in the research field (60%).

Interviews may be required for the top-three scoring candidates. If so, the interview will be scored at 50%.
