1. Scientific area: Biological Sciences


#### 2. Admission requirements:

The candidate will be responsible for supporting the development of Policy Briefs about good practices and social licensing of seaweed farming, as well as supporting the seaweed stock assessment and other on-going work at the laboratory. The candidate will also be responsible for the analysis of the results and writing reports, as well as writing the scientific papers.

- **6. Duration of the grant**: Duration of six (6) months, starting October 2018, under the regime of exclusive dedication, eventually renewable according to legal terms.


#### 8. Selection methods:

Ranking of the candidates will be performed by CV evaluation (CE), according to the following criteria: C1 (Experience in benthic intertidal organisms in situ monitoring/observations, sampling and identification particularly of seaweed); C2 (Experience in intertidal seaweed stock assessments); C3 (Experience in intertidal seaweed stock assessments) and C4 (Good level of English and in soft skills), each of these factors weighting as follows:

- C1 (30%)
- C2 (30%)
- C3 (20%)
- C4 (20%)

Ranking will be obtained from the following formula:

 $CE = 0.3 \times C1 + 0.3 \times C2 + 0.2 \times C3 + 0.2 \times C4$ , expressed in a scale of 0 to 20 points.
