RESEARCH GRANT (BM) (1 vacancy)

A competition is open for the attribution of one Research Grant in the framework of the project **MARINFO - Integrated Platform for Marine Data Acquisition and Analysis reference** NORTE-01-0145-FEDER-000031 within the R&D Institution CIIMAR (Interdisciplinary Centre of Marine and Environmental Research), supported by the Northern Regional Operational Programme (NORTE2020), through the European Regional Development Fund (ERDF), according to the following conditions:

1. Scientific area: Biological Sciences

2. Admission requirements

- The candidates must hold a Master Degree in the field of in Biological Sciences or related fields with minimum final classification of 14/20.
- The candidate must have technical and scientific training in Marine Ecology. A strong background in subtidal ecology is considered advantageous.
- A demonstrated capacity to perform data analysis, prepare reports and write manuscripts is desirable. Fluency in English is expected.
- Diving license and demonstrated expertise in underwater research is required.

1. Work plan:

The candidate will work on the Task 2, Research Line 2 of the project MARINFO-Integrated Platform for Marine Data Acquisition and Analysis, entitled "Upwelling and climate change effects on marine ecosystems". The research plan will focus on combining monitoring and experimental approaches to measure benthic diversity and primary production. The candidate will collaborate in the design and test of a underwater metabolic chamber.

3. Work place:

The work will be carried out at CIIMAR, Novo Edifício do Terminal de Cruzeiros do Porto de Leixões, Av. General Norton de Matos, s/n, Matosinhos, Aquatic Ecology & Evolution Group, under the scientific supervision of PhD Francisco Arenas.

4. Duration of the contract: 6 months

5. Duration of six (6) months, starting August 2017, under the regime of exclusive dedication, eventually renewable 12 months more (or the end of the project, whatever happens earlier) according to legal terms.

6. Monthly salary:

The monthly maintenance allowance is $\notin 980$ (nine hundred and eighty Euros – Tax Free), in agreement with the monthly maintenance stipend table of the grants directly attributed by FCT, I.P. within the country (http://www.fct.pt/apoios/bolsas/valores.phtml.en).

7. Selection methods:

The ranking of candidates will be performed by a global evaluation based on:

- Evaluation of the Curriculum Vitae 60%;
- Experience in the research field 40%;
- An interview will be conducted in the case of a tie (only the 3 short listed candidates will be interviewed). If so, the final classification will result from: CV (60%) and interview 40%.
