ASSISTANT RESEARCHER WORK CONTRACT (1 vacancy)

A competition is open for the attribution of 1 work contract vacancy to an Assistant Researcher in the framework of the NORTE-01-0145-FEDER-000031, with reference MarInfo – Integrated Platform for Marine Data Acquisition and Analysis, within the R&D Institution CIIMAR (Interdisciplinary Centre of Marine and Environmental Research), supported by the Northern Regional Operational Programme (NORTE2020), through the European Regional Development Fund (ERDF), according to the following conditions:

1. Scientific area: Biological Sciences

2. Admission requirements:

The candidate must hold a PhD Degree in the field of in Biological Sciences, Marine Sciences or related fields. The candidate must have strong technical and scientific training on molecular biology, and evolutionary analyses.

Very good fluency in English is expected and demonstrated experience in senior research project management, to prepare reports and write manuscripts.

1. Work plan:

The candidate will be involved in the integration, interpretation, discussion of results and preparation of manuscripts of a large volume of biological biodiversity (from multiple organisms) from data already available in the scope of the project. Additionally, the candidate will be also involved in intensive laboratorial work (DNA extraction, PCR, sequencing) and data analysis resulting from new samplings.

Supervision of graduate/post-graduate students is also expected.

3. Work place:

The work will be carried out at CIIMAR.

4. Duration of the contract:

Starting January 2018, under the regime of full time, according to the end of the project and legal terms - contract of limited duration – 12 months; (articles n.° 140°, n° 1 and n° 2, h) and article n.° 148°, n° 1 – Labour Code).

7. Monthly salary:

The gross monthly salary is €2127,88 (two thousand one hundred and twenty seven Euros and eighty eight cents), in agreement with the research career; food, holidays and Christmas allowance apart.

8. Selection methods:

The ranking of candidates will be performed by a global evaluation based on: the evaluation of the Curriculum Vitae (70%) and experience in the research field (30%). Interview may be required for the top-three scoring candidates. If so, the interview will be scored at 50%.
