A competition is open for the attribution of 1 Research Grant (BM) in the framework of the project *Nor-Water: Poluentes emergentes nas águas da Galiza-Norte de Portugal: novas ferramentas para gestão de risco*, reference 0725_NOR_WATER_1_P, supported by Programa de Cooperação Interreg V-A Espanha/Portugal (POCTEP) 2014–2020, according to the following conditions:

1. Scientific area: Biological Sciences

2. Admission requirements


- (i) The candidates must hold a master's degree in the field of in Biological Sciences or related field with classification equal or higher than 15 values (in 20);
- (ii) The candidate must have technical and scientific knowledge on the use of experimental systems in marine sciences, experience in conducting ecotoxicological assays with marine and freshwater organisms. Experience with the following animal models is an advantage: marine amphipods, rotifers, zebrafish. The candidate should have experience evaluating the effects of aquatic pollutants using molecular markers.
- (iii) Very good fluency in English is expected.

3. Work plan:

The candidate will mainly be involved in:

- Laboratory maintenance of test organisms to be used in the experimental work;
- Conduction of ecotoxicological assays with marine and freshwater organisms;
- Determination of molecular biomarkers;
- Participation in the development of experiments in collaboration with other partners of the project;
- Perform data analysis

The work will be carried out at CIIMAR, Av. General Norton de Matos, s/n, Matosinhos,

under the scientific supervision of Prof. Miguel Santos and Dra Teresa Neuparth.

6. Duration of the grant:

Duration of twelve (12) months, starting in December 2019, non-renewable, under the

regime of exclusive dedication.

7. Monthly maintenance stipend:

The monthly maintenance allowance is €989,70 (nine hundred and eighty nine Euros and

seventy cents - Tax Free), in agreement with the monthly maintenance stipend table of the

8. Selection methods:

The ranking of candidates will be performed by a global evaluation based on the evaluation

of the Curriculum Vitae (40%) and experience in the research field (60%).

If necessary, an interview will be done to the three top candidates, after which a final

ranking will be performed based on CV and research experience (50%) and Interview 50%.


