A competition is open for the attribution of one Research Grant in the framework of the project ValorMar - Valorização Integral dos Recursos Marinhos: Potencial, Inovação Tecnológica e Novas Aplicações, with the reference 24517 (10/SI/2016 – I&DT Empresarial – Programas Mobilizadores) within the R&D Institution CIIMAR (Interdisciplinary Centre of Marine and Environmental Research), supported by the European Regional Development Fund (ERDF) and by the European Social Fund (ESF), according to the following conditions:

- 1. Scientific area: Biological Sciences
- 2. Admission requirements:

• Candidates must hold a Master Degree in the field of Biological Sciences or related fields with minimum final classification of 14/20.

• Candidates must have technical and scientific training in Marine and Fish Ecology. A strong background in experimental work, particularly fish rearing trials is considered advantageous.

• A demonstrated capacity to perform data analysis, prepare reports and write manuscripts is desirable. Fluency in English is expected.

• Candidates must have certification for animal experimentation.

3. Work plan:

The candidate will work on the Task 2 of PPS4 of the project ValorMar – *Valorização Integral dos Recursos Marinhos: Potencial, Inovação Tecnológica e Novas Aplicações.* The research plan will focus on search and selection of parameters used for the elaboration of the freshness/quality index, experimental work (namely fish trials) and laboratorial work (i.e. samples processing, biochemical analysis, and other analytical work).

5. Work place:

The work will be carried out at CIIMAR, Novo Edifício do Terminal de Cruzeiros do Porto de Leixões, Av. General Norton de Matos, s/n, Matosinhos, under the scientific supervision of Dr Patricia Cardoso and Dr Rodrigo Ozório.

6. Duration of the contract: 6 months

Duration of six (6) months, from February 2018, under the regime of exclusive dedication, eventually renewable to a maximum of two (2) years.

7. Monthly salary:

The monthly maintenance allowance is €980 (nine hundred and eighty Euros – Tax Free), in agreement with the monthly maintenance stipend table of the grants directly attributed by FCT, I.P. within the country (http://www.fct.pt/apoios/bolsas/valores.phtml.en).

8. Selection methods:

The ranking of candidates will be performed by a global evaluation based on:

- Evaluation of the Curriculum Vitae 60%;
- Experience in the research field 40%;
- An interview will be conducted in the case of a tie (only the short listed candidates will be interviewed). If so, the final classification will result from: CV (60%) and interview 40%.
