

## **RESEARCH GRANT (BPD) (1 vacancy)**

**Reference: MobFood/BPD/2019-056**

A competition is open for the attribution of 1 Research Grant ref. MobFood/BPD/2019-056 in the framework of project **MOBFOOD – Mobilização de conhecimento científico e tecnológico em resposta aos desafios do Mercado agroalimentar**, with reference 24524 (10/SI/2016 - I&DT Empresarial - Programas Mobilizadores), supported by the European Regional Development Fund (ERDF) and by the European Social Fund (ESF), according to the following conditions:

**1. Scientific area:** Biological Sciences

### **2. Admission requirements**

The candidate should have:

- 1) A PhD degree in the field of Biological, Biochemical or Biomedical Sciences, or in a related field and meet the requirements of at least one of the paragraphs below;
- 2) Technical and scientific knowledge on fish nutrition and aquaculture;
- 3) Capacity to perform molecular biology techniques autonomously;
- 4) Experience in bioactivity screening or molecular effects of compounds, including chemical analysis of biological materials;
- 5) Demonstrated capacity to perform data analysis, prepare reports and write manuscripts;
- 6) Proven record of organisational responsibilities and evidence of successful leadership initiatives;

In the event the doctorate degree was awarded by a foreign higher education institution, said degree must comply with the provisions of Decree-Law no. 66/2018 of 16th August until the signature of the contract.

### **3. Work plan:**

The candidate will be responsible for the development and implementation of strategies to evaluate and valorize agro-food by-products as ingredients for fish diets. The successful applicant will strengthen existing national collaborations and networks with industrial partners, but should also create new initiatives to support and manage new research activities. The candidate will be particularly involved in the development and

evaluation of the nutritional value and bioavailability of nutrients in several ingredients using a market-oriented approach. The production of added value and innovative sea food items is a major objective. The candidate will prepare reports and write manuscripts for publication in international journals.

#### **4. Legislation and official rules:**

Law nº. 40/2004, 18th August (Research Fellowship Holder Statute); FCT Regulation for Research Studentships and Fellowships and CIIMAR Grants Regulation.

#### **5. Work place:**

The work will be carried out at CIIMAR, Laboratory of Nutrition, Growth and Quality of Fish (LANUCE) under the scientific supervision of Prof. Luisa Valente.

#### **6. Duration of the contract:**

Duration of six (6) months, under the regime of exclusive dedication, eventually renewable according to legal terms, up to 12 months.

#### **7. Monthly salary:**

The monthly maintenance allowance is €1509.80 (one thousand five hundred and nine Euros and eighty cents– Taxes Free), in agreement with the monthly maintenance stipend table of the grants directly attributed by FCT, I.P. within the country (<https://www.fct.pt/apoios/bolsas/valores.phtml.en>).

#### **8. Selection methods:**

The ranking of candidates will be performed by a global evaluation based on:

- Evaluation of the Curriculum Vitae -30%;
- Experience in the research field – 30%;
- Interview – 40% (Only the 3 short listed candidates will be interviewed).
