On the 15th of February 2018, the jury composed by Dr Francisco Arenas (president of the jury), Dr Elsa Froufe and Dr Patricia Cardoso met at CIIMAR, Terminal de Cruzeiros do Porto de Leixões - Matosinhos, to evaluate the curricula and merits of the candidates to the research grant with reference MARINFO/BI/2018-069. This grant will be signed in the framework of the project **MARINFO - Integrated Platform for Marine Data Acquisition and Analysis** reference NORTE-01-0145-FEDER-000031 within the R&D Institution CIIMAR (Interdisciplinary Centre of Marine and Environmental Research), supported by the Northern Regional Operational Programme (NORTE2020), through the European Regional Development Fund (ERDF).

The unique point in the agenda of the meeting was the evaluation and classification of the candidatures. The secretary at CIIMAR received 9 candidatures: 1. Ahsan Hameed, 2. Ana Porfírio, 3. Cátia Castro, 4. David Dinis, 5. Friederike Peiffer, 6. Giulia Secci, 7. Inês Pereira, 8. Joana Moreira and 9. Mónica Fabra.

In accordance to admission requirements, four candidatures were excluded: Ahsan Hameed, Cátia Castro, Inês Pereira and Joana Moreira did not accomplish some of the requirements included in the initial call (diving certificate).

The seriation of the candidates was performed according to the following evaluation criteria:

- 1) Evaluation of Curriculum Vitae (60 %): up to 6 – insufficient, 8 – poor, 12 – reasonable, 14 – good, 18 – very good, 20 – outstanding
- 2) Experience in the research field (40 %): up to 6 – insufficient, 8 – poor, 12 – reasonable, 14 – good, 18 – very good, 20 – outstanding

The seriation of the candidates was performed according to the evaluation criteria detailed in the position announcement. Hence the valid candidates were ranked as following:

Ana Porfírio CV – 7.2 / Experience – 4.8 / **Total - 12**

David Dinis CV – 7.2 / Experience – 5.6 / **Total – 12.8**

Friederike Peiffer CV – 10.8 / Experience – 7.2 / **Total – 18**

Giulia Secci CV – 9.6 / Experience – 5.6 / **Total – 15.2**

Mónica Fabra CV – 7.2 / Experience – 3.2 / **Total – 10.4**

Thus, the jury decided that, if it is found that no candidate deducts any objection within the statutory period, this decision will become final and is automatically proposed the candidate Friederike Peiffer.

This decision will be communicated to candidates, granting them a period of ten days to consult the process and contest the decision in writing, in case of disagreement.
